Summary of Decisions reached at WPDD 10th Meeting – (November 17-19 2009)

AGENDA ITEM	DECISION
4.a Participation of Indian representatives in WPDD activities	Subject to resolution of procedural issues by NEA Steering Group, WPDD welcomes involvement by representatives from India in its activities
4.e CPD Report on D&D of Concrete	This was approved in principle for publication subject to a review of the final draft by the WPDD Core Group. Any further comments are to be provided to Secretariat by end December
6.a Map of International Activities	This will be posted on the WPDD open web page by end December, subject to: The incorporation of inputs from IAEA Safety section and DG-TREN and any comments from members (asap)
6.b Decommissioning Brochure	Members were invited to publish the brochure in their own language: Formal requests must be submitted to OECD-NEA. Japan and Finland, indicated an intention to publish national versions
8.a Decommissioning Cost Study	We have approval to publish the Cost Drivers and Reporting Requirements Report, subject to the addition of text on cost implications of contracting strategies [to be developed by Alan Neal/Secretariat] . The duration of the DCEG mandate was extended to 31 December 2010. The remit itself remains unchanged.
8.b Study ' <i>Applying lessons from decommissioning to new build</i> '	The Joint NEA/IAEA booklet was approved for publication, subject to: any comments received from WPDD by end December 2009
8.c Task Group on R&D of decommissioning techniques	Any additional interest in participation is to be manifested to G. Laurent/P. O'Sullivan before the kick-off meeting (early January 2010) (H. Maxeiner, NAGRA, will participate) TOR is to be further developed by the Task Group, taking account of comments at WPDD-10
8.c Task Group on large component disposal issues	The Task Group will consider the comments provided during the topical session in taking forward the project. Initial conclusions from the study will be reported and discussed at WPDD-11
10.b Environmental Remediation	It was agreed that environmental remediation (in the sense of a final step in a D&D project) was within the WPDD scope The Core Group (with special input from D. Metcalfe) will discuss what type of work could be undertaken by the WPDD and report to WPDD-11

10.c Recycling of Scrap Metal	The possible risk to implementing clearance due to non-acceptance of cleared material by the metal industry was noted WPDD will maintain a watching brief on the development of international protocols
10.d Characterisation	The proposal was accepted in principle – a more detailed proposal will be brought for decision to WPDD-1. A detailed proposal will be developed by H. Efraimsson (co-ordinator), P. Orr, M. Dutzer & G. Laurent (or representatives from their organisations)
12. WPDD Strategic Outlook	WPDD Core Group will develop a draft Strategic document for 2011-2016, taking account of feedback received from the membership Strategic document will be presented for approval at WPDD-11
