TERMS OF USE OF THE TAF-ID PUBLIC VERSION

THE COMPILED INFORMATION (AS DEFINED BELOW) IS PROVIDED SUBJECT TO THESE TERMS OF USE (HEREINAFTER THE "TOU"). BY SIGNING THE TOU, YOU (HEREINAFTER REFERRED TO AS THE "USER") REPRESENT THAT YOU AGREE TO BE BOUND BY THE TOU.

The User is informed that the Compiled Information (as defined below) is provided within the framework of the OECD Nuclear Energy Agency (hereinafter the "OECD-NEA") Thermodynamics of Advanced Fuels – International Database Project which started on 1 January 2013 (herein referred to as the "TAF-ID Project"). The purpose of the TAF-ID Project is to establish an international database of thermodynamic data for advanced nuclear fuels and cladding materials.

Through the following webpage, the User will have access to a variety of information and resources pertaining to the TAF-ID Project, including data and databases which, taken individually, are generally available to the public but which have been collected, assembled and selected in a way that constitutes an original work of authorship (herein referred to as the "Compiled Information").

Right of Use, Confidentiality and Intellectual Property Rights

The User agrees not to disclose the Compiled Information in whatever form to any third party (including, but not limited to, directly or indirectly distributing, transmitting, displaying, performing, reproducing, publishing, licensing, transferring, copying or selling the Compiled Information). For example, users are not permitted to put the Compiled Information on a shared computer which allows other users to access the Compiled Information (neither free of charge or by paying a royalty for its use).

If the User makes any improvements to the Compiled Information, the User must inform the OECD-NEA and shall not have the right to sell the improved Compiled.

Before holding training courses/classes or workshops using the Compiled Information, the OECD NEA must be consulted and a specific authorisation must be obtained.

Access to the Compiled Information shall only be given by the OECD-NEA, upon acceptance and return of the present TOU duly completed and signed by the User.

The Compiled Information is provided on the condition that whenever its use results in a publication (a journal, conference, proceeding, laboratory report, book, etc.), the TAF-ID Project shall be acknowledged in the publication.

Feedback

The User is invited to report back to the OECD-NEA with the following information concerning the Compiled Information received:

- Possible errors or inconsistencies between the database and its documentation;
- Limitations found in its applicability not reported in the documentation.

This information will be used to update and maintain the quality of the Compiled Information.
